If you are unable to submit your payment through Intuit, you can make a debit payment directly on the [California e-Service site](#).

To use e-Services, you must register with California Employment Development Department (EDD) e-Services program in order to e-file Form DE 88. You'll need the following information to complete the e-Services registration:

- 8-Digit CA EDD Employer Account Number
- Unemployment Insurance (UI) Rate
- Company Zip Code

To enroll in California EDD e-Services:

You only need to enroll once for e-file and e-pay.
